Our Lady of Good Counsel students are highly encouraged to use the school bus. Please read the following information for the 2009-2010 school year:

1. School Bus Fees
\$ 450.00 per semester for morning and afternoon transportation
\$ 225.00 per semester for morning or afternoon transportation
\$ 3.00 for single ride for non-bus pass holder
2. School Buses will leave school at 3:30 pm. If school is dismissed for any reason (either scheduled or unscheduled), the school bus will leave approximately ½ hour after dismissal time. During exams the bus will also leave ½ hour after the last scheduled exam of the day. **There will be no school bus scheduled for the Exam Makeup Day.**
3. **Please be at your stop five minutes early** and be visible to the school bus driver. The School Bus Schedule is on the back of this handout.
4. School Bus Passes will be issued. There will be a **\$10.00 fee** to replace lost or damaged passes. **Please complete the SCHOOL BUS ENROLLMENT FORM and return it to the Business Office as soon as possible if your child is planning to ride the Good Counsel School Bus.** The bus driver has a roster based on the SCHOOL BUS ENROLLMENT FORMS submitted to the Business Office.
5. Students are permitted to pay the bus driver \$3.00 for a single bus ride on a space available basis. The \$3.00 (single ride) tickets are also available in the Business Office.
6. All school bus riders are expected to conduct themselves in a manner consistent with behavior in the classroom or at any school related activity. Food, drink and/or gum are prohibited on the school bus. Inappropriate behaviors such as use of profane language, standing while the bus is in operation, vandalism, loud or rambunctious activity, as well as any other behavior inconsistent with proper student conduct is unacceptable. Infractions will be reported to a Dean of Students or an administrator who will take appropriate disciplinary action that may include suspension of bus riding privileges for periods of one day to an indefinite ban from riding, as well as additional disciplinary action.
7. **THE GOOD COUNSEL SCHOOL BUS BEGINS THE FIRST DAY OF SCHOOL ON MONDAY, AUGUST 23, 2010.**
